



### **What is this program?**

The Mandel Myers Fellowship is a unique program designed to encourage Jewish Cleveland's college students to work at Jewish overnight camp and develop into future Jewish leaders. This is a program of the Jewish Federation of Cleveland and operates in partnership with Jewish Family Service Association of Cleveland. This Fellowship is generously funded by the Jack, Joseph and Morton Mandel Foundation and the David and Inez Myers Foundation. This program has two important components:

1. Learning workshops that are filled with a rich curriculum centered around applied professional and leadership development, Jewish learning explorations, and intentional networking opportunities to connect the experience of working as overnight camp counselor to career skills.
2. A college scholarship of up to \$5,500 or \$4,500 to offer future Jewish leaders a meaningful opportunity that may have previously been too financially burdensome or unaffordable.

### **What are the dates of the program?**

The program application will be available December 30, 2024, and will close April 1, 2025. Attendance is required at three professional development workshops. Dates will be announced in January 2025.

## **Who is this program for?**

This program is for students who meet the following criteria:

1. Identify as Jewish
2. Reside in the greater Cleveland, Ohio area OR is a U.S. Resident with a signed employment contract with Camp Wise, a program of the Mandel Jewish Community Center OR is enrolled in a university or college affiliated with Cleveland Hillel or Hillel at Kent State University
3. Have a signed contract with a Jewish overnight summer camp in North America (U.S. or Canada) that is on the approved camp list below
4. Are enrolled full-time in an in-person, accredited university for Fall 2025 seeking a bachelor's or master's degree

## **What is the scholarship amount?**

First-time counselors are eligible for up to \$4,500.

Returning counselors are eligible for up to \$5,500.

To receive the full scholarship amount, participants must complete a full summer at camp (at least 8 weeks), attend all required learning workshops, and complete all required activities/projects.

## **What if my camp only offers half summer employment?**

For camps that only offer half summer employment, a prorated scholarship will be awarded.

## **What if I am only able to work a partial summer at camp?**

If you are only able to work a partial summer, please contact your camp to discuss the opportunity and a decision on acceptance into this program will be made on a case-by-case basis.

## **What if I am enrolled in a gap year program following my summer at camp?**

### **Is this a needs-based scholarship?**

No, this scholarship is an investment in all rising Jewish Cleveland leaders who make a commitment to being a camp counselor at an eligible camp regardless of financial situation. If you meet the criteria above, you are eligible for this scholarship.

### **When will the scholarship funds be sent?**

The scholarship is split into two parts. The first half will be sent to the school in August and the second half will be sent to the school in December. Each student will be responsible for reaching out to their school's financial aid office to confirm that the Mandel Myers Fellowship Scholarship will not negatively impact any financial aid from the school or another outside source.

### **Do I have to complete my summer at camp to receive the scholarship?**

Yes! This fellowship requires that students complete their full contract with their camp to develop all relevant skills and fulfill their commitment to camp.

### **Do I have to attend all learning workshops?**

Yes! The learning workshops will build on each other to create a full fellowship experience. Attendance at all three learning workshops is required to receive the full scholarship. Please make every effort to attend the sessions in person, as the experience is most meaningful.
